- 1. **<u>APPLICATION FEE-</u>** The application fee is non-refundable. You have delivered to us an application fee of <u>\$50</u> per person over the age of 18; this payment partially defrays the cost of processing the application.
- 2. **ADMINISTRATIVE FEE** The administrative fee in the amount of **\$199** is a non-refundable fee with an approved application, unless application is withdrawn within 72 hours of approval.
- SECURITY DEPOSIT In addition to the application fee and administrative fee, you have left us a security deposit in the amount of \$_____. If approved and the rental unit is held for more than 72 hours and the applicant then withdraws the application all monies will be forfeited.
- 4. **<u>APPROVAL WHEN LEASE ISN'T SIGNED YET</u>** If you and all co-applicants have not signed the lease, when we approve the application, we will notify you or one of your co-applicants, of the approval. All occupants must sign the lease before any keys will be given out for the new home.
